Plan Summary [2024-25]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

La Vida Charter School is small K-12 blended program of Home Study and On-site classes two days per week. It is a member school of the Alliance for Public Waldorf Education which inspires the educational approaches and quality of the on-site classes. Often described as a “sweet place” the campus is in the heart of the county on Ridgewood Ranch, Home of Seabiscuit, on Highway 101 between Willits and Ukiah. The population comes from all over the county and beyond. Mendocino, Covelo, Laytonville, Potter Valley, Booneville, Hopland, Santa Rosa, Clearlake and Blue Lakes in Lake County as well as Willits, with the largest group from Ukiah. Usually a highly mobile population, however last year there was slightly less movement with 89 enrolled through the entire year with a Spring enrollment of 76, La Vida serves by offering an alternative to mainstream district schools and does a good job of personalizing each educational program. The school provides a full complement of independent study curriculum and a credentialed teacher is assigned to each student. There are over 240 courses available in the High School Course Catalog. The school has been serving for 22 years and is WASC, Western Association of School's and Colleges Accredited . The current charter term will end June 30, of 2027.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

La Vida provides two standardized tests, the MAP, Measures of Academic Progress, and California SBAC, Smarter Balanced Assessment Consortium. La Vida prefers the MAP test because it reflects what each student knows and charts growth.

The state test reporting on The California Dashboard is fraught with problems and inaccuracies. For one there should be no posting information about the school's SBAC results since less than 11 students in each grade level are enrolled and test. The results also do not reflect the levels of the students because it heavily penalizes points if less than 95% participation. Parents have the right to waive the test, and the state penalizes that right. It doesn't give credit to students for completing individual tests. As a result, much of the Dashboard information is skewed.

The school is very pleased to have reached it's goals of 70% growth in Math and 60% growth in Reading (74% & 64% respectively.) Even though most students would be described as low performing, their growth is significant.

Board	<p>The ongoing monthly discussions for school improvement came into focus at the April 10th meeting where the Board approved the purchase of the Reading and Math intervention My Path program. Also at this meeting the Board created a list of reflection questions for parents to assess their motivation and ability to do homeschooling. There has been a shift in the mindset of parents regarding student achievement. This list helped frame the discussion at the Parent Tea and LCAP survey questions.</p> <p>Suggestions on creating Elective Intensives for the High School afternoon classes rather than the trimester long classes was brainstormed with the board and then later with the other stakeholders.</p>
Faculty	<p>At the faculty monthly EC meetings there was also an ongoing troubleshooting discussion about student achievement that is influenced by parent dedication or lack thereof.</p> <p>At the April 17 meeting the Faculty were introduced to the My Path and Newsela interventions as an action response to their inquiries. Feedback was positive and hopeful. The list of questions for parents that the board had created were reviewed, discussed and developed. Later at the June 6 EC Staff meeting there a long discussion review in small groups of the WASC goals for the year which are intertwined with the LCAP. Office Staff	Office staff input was more informal, with regular brainstorming along the way as the board and faculty ideas were developed.
Parents	<p>Parents- Parent Tea on May 7 reflected on the successes of the year and challenges. The concerns of the students academics levels were presented along with the ideas for interventions. There was interest and positive feedback. More ideas and discussion about the redesign of the High School elective classes were explored with helpful suggestions.</p> <p>The Parent Survey this year incorporated several questions developed by the board in April. Parents provided actionable feedback on the interventions. 85% said they wanted to participate and the others felt they didn't need it.</p> <p>At the Curriculum Fair June 13, there were posters and brochures on the intervention programs which sparked many little conversations and inquiries.</p>

For many years students enter La Vida below grade level. It is not uncommon to have students in a math class that is one or more years below their chronological grade level. In order for students to grow to their best selves and achieve their dreams and goals, lots of extra support is needed. Making sure that all students have access to the full range of supports that are available is also important. Equal access can also mean having the emotional resilience, and confidence to reach for educational opportunities that may be out of ones comfort zone. Providing both academic and emotional learning support is necessary for many students to succeed. The school has found that working with the student's strengths and acknowledging accomplishments builds confidence and creates an upward momentum.
