## **DIRECTOR'S REPORT:** May be expanded at the meeting.

**Enrollment**: 73, two gains and two losses. Two more are in the enrollment process. Opening in high school.

**Financials:** The cash was rolled over from last year to this year after the closing or Unaudited actual report was submitted. The first financial period closed October 31. The first interim budget will be on the December Agenda for approval.

**Audit:** Draft 1 of the 2021-22 Audit was received and is in review. It will be on the December agenda for discussion and approval.

**Academics:** The fall MAP session is finished for high school, but elementary is still in Process. Approximately 33% of the students are enrolled in tutoring.\*

**Willits Unified:** Superintendent Mark Beebe has been invited to the Fall Play and Festivities. We hope he will be able to attend this year.

**Special Ed**: Held 4 IEPs, two were initals.

The assigned Social Worker/ counselor has been changed to someone who speaks Spanish.

We have a new in- person school nurse through the county, Holly Hutchenson who Commutes from Humboldt County. She will do a vision and hearing screening for The elementary school on December 5<sup>th</sup>.

**Teachers** EC's continued with a peer review of files. For the most part they look good, however some errors were seen.

Turn in of the EC files was Friday.

Two teachers were out for two days each. Other teachers subbed for them.

**Staff**: The annual CBEDs report for student data snapshot was submitted to the state on time.

Estie, the new class aid and Spanish speaking support has been a great positive addition to the staff. She was the lead on the Pumpkin Express and Pumpkin Patch Field trips as Well as for the Scarecrow.

**Parents:** Two families have been very generous with bringing snacks, juice, milk etc For the students. Twenty or so parents attended the Pumpkin Express Field Trip for the Primary grades. It was a lovely day.

**Students:** School pictures happened and are already available with Maureen Jennison. Lots of enjoyment was seen with the creation of Jester the Scarecrow who received The Extraordinary Scarecrow Ribbon. All onsite classes contributed, with the high School students making him come to life with many details. October ends with Dias De Los Muertos this year.

**Coming up:** Next Board Meeting December 6 at 6pm. Veteran's Day Holiday is Friday 11-10. Thankfulness Feast and Fall Performance is 11-14 at 11:30 am.
