There was a short EC Staff meeting looking at problems with the Personal Learning System. Then the annual Pot Luck lunch and White Elephant Gift Exchange which was quite tame this year.

Staff: CALPADS Fall 1 was submitted on time. Attendance P-1 was submitted this week.

Students: SMART Goals Awards Assembly: 17 students received award certificates and dragon wooden coins that could be spent at the student store.

Community Thursday worked out amazingly well because of the faculty group effort to cover for the lead teacher who resigned. *

RSV (Respiratory Syncytial Virus) and Covid were going around before break. Both students and staff were out.

Fire Drill for Elementary onsite occurred.

Special Ed: 4 IEPs were held. New this year is Assistive Technology Assessments and Support through Partners in Special Education. Our students are receiving ipads with predictive writing and read aloud functions Plus a C Reader Pen that reads aloud when scanned over text.

Site: Phone outages- before winter break, a squirrel's nest on the line, then during winter break- a cable down and had to be replaced.

Technology: The testing computers are getting old and were not quite strong enough to support the Robotify class. New Ram and Solid State Drives were installed which have helped a lot. A few new computers for students are being acquired in the near future.

Coming up: Willits Board Meeting is January 11th with the review of the End of Year Reports for the Charter Schools. Next Board Meeting February 7. **Benchmark Project Fairs:** January 25th for High School and January 30th for Elementary.
