# **DIRECTOR'S REPORT:**

**Enrollment**: 62 with openings Grades 9, 10 & 11. There were three losses, one student moved and two were disenrolled for non-compliance. There are seven possible new enrollments at different stages.

**Financials** - The Business Manager is working on the Funding Determination which is Due February 1<sup>st</sup>. It is a high stakes report for the school's funding for the next several years.

CDE LEA Audits- Still no word that the last approval is complete. However, it is expected any day.

Audit: The audit was submitted on the due date. Approval was in the consent agenda. of this meeting.

CALPADS Fall 1 report and the P-1 Attendance report was filed on time P-1 ADA was 57.43. Apportionment adjustment will be in February.

A meeting with Willits Unified and Mendocino County SELPA is coming up to discuss La Vida receiving the Special Ed 602 Funds.

Academics: The Elementary Benchmark Project Fair is Januaty 28. This is an important project for students in grades 1-8, 9-12 will be in the spring.

The La Vida Endo of Year Report was presented to the Willits Board on January 9 which includes a focus on prior year Academic Growth. Last year there was 58% growth in Reading and 64% growth in Math. (60% is the goal) On the CAASPP there was approx.. 64 point growth in ELA and Math.

Gary Martin is funded again by the Mendocino Arts Council to bring once per month presentations on the History of Art.

Preparations for the ELPAC Test in February.9for English Language Learners)

Six High School Students participated in the Digital Story Telling Intensive on Seabiscuit. They did a nice job on their presentations.

**Teachers:** Eugene Schwartz's important article on Waldorf At War in the New View magazine was discussed at the Teacher Learning Community. Eugene may continue his mentorship with the faculty later this year.
